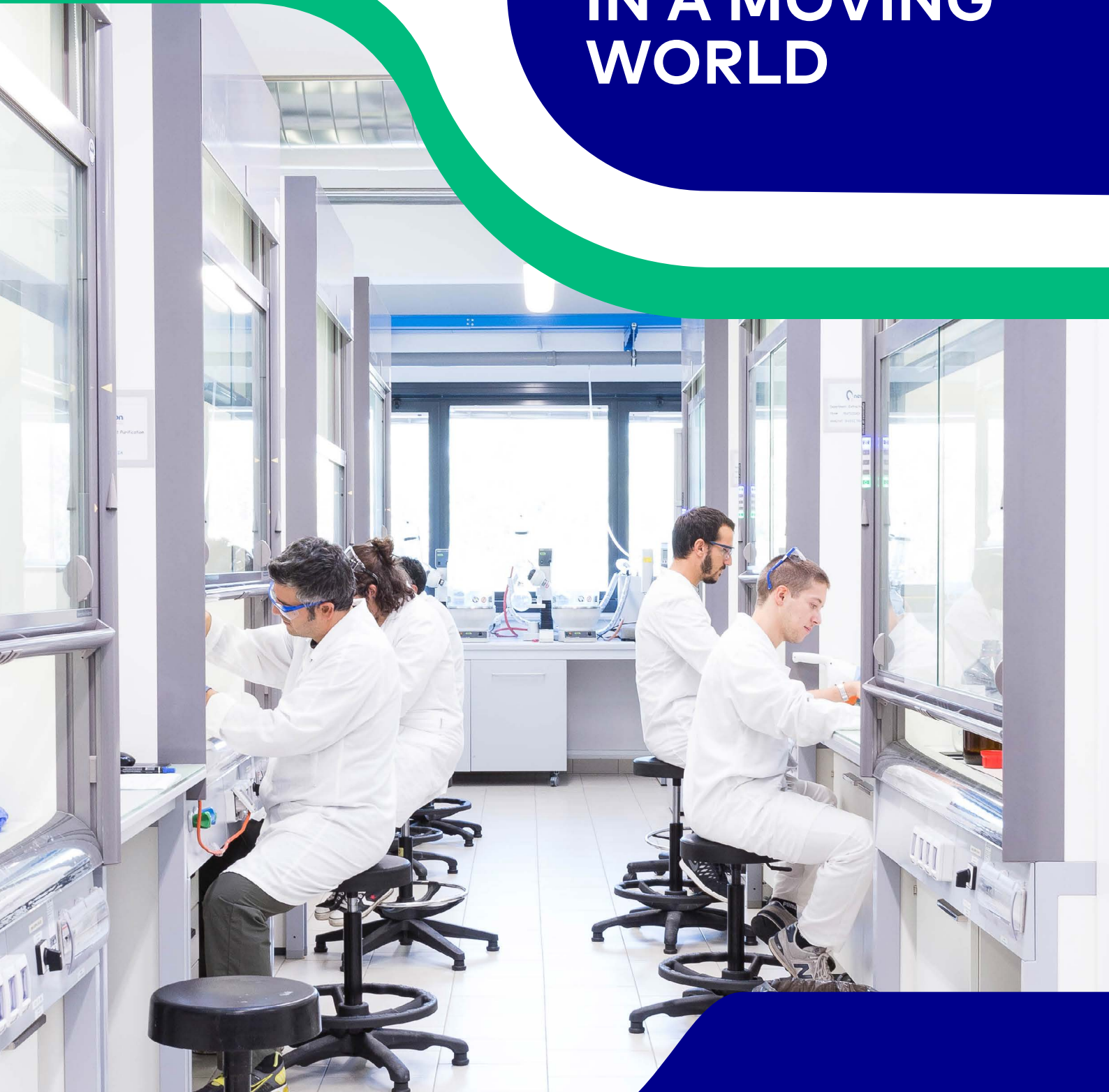

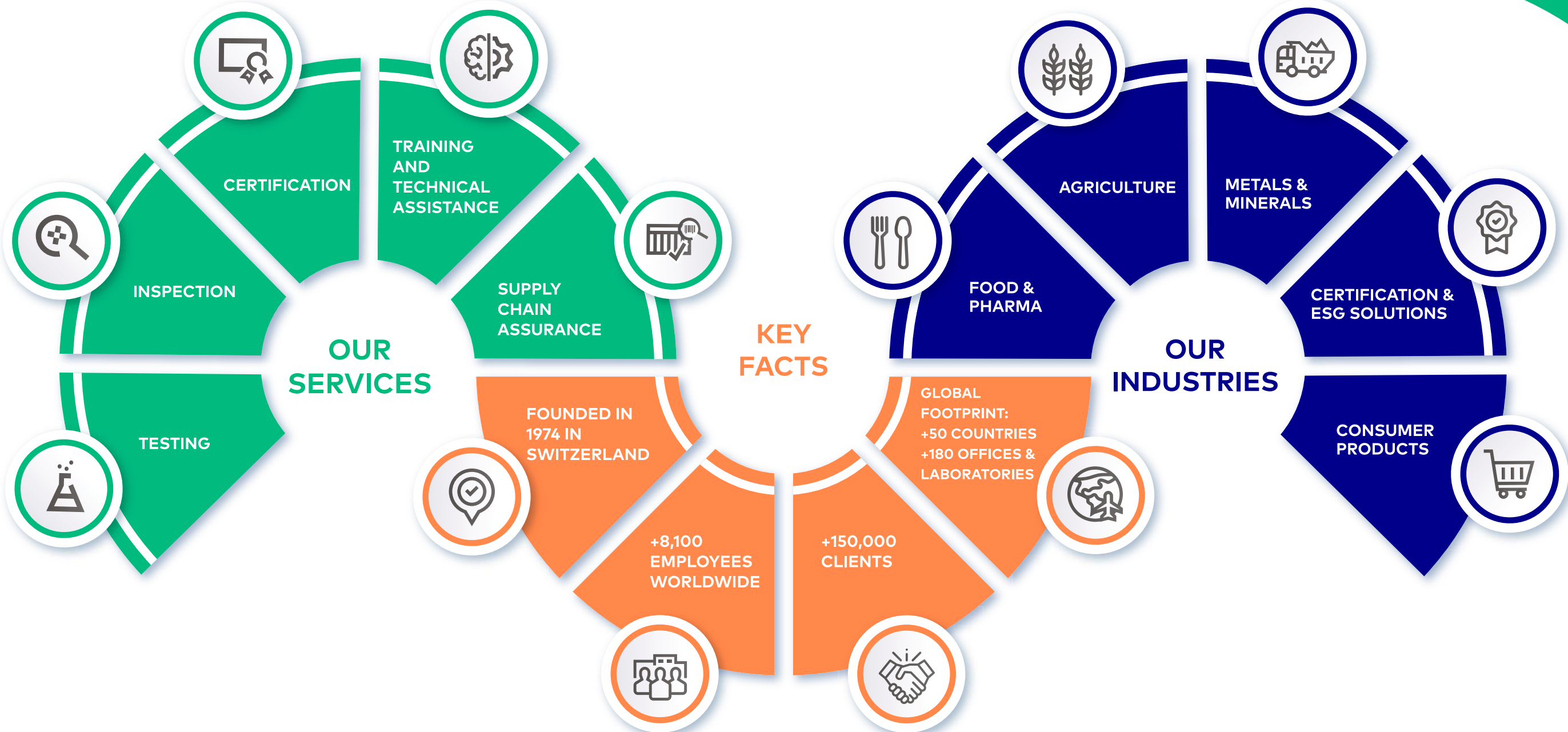

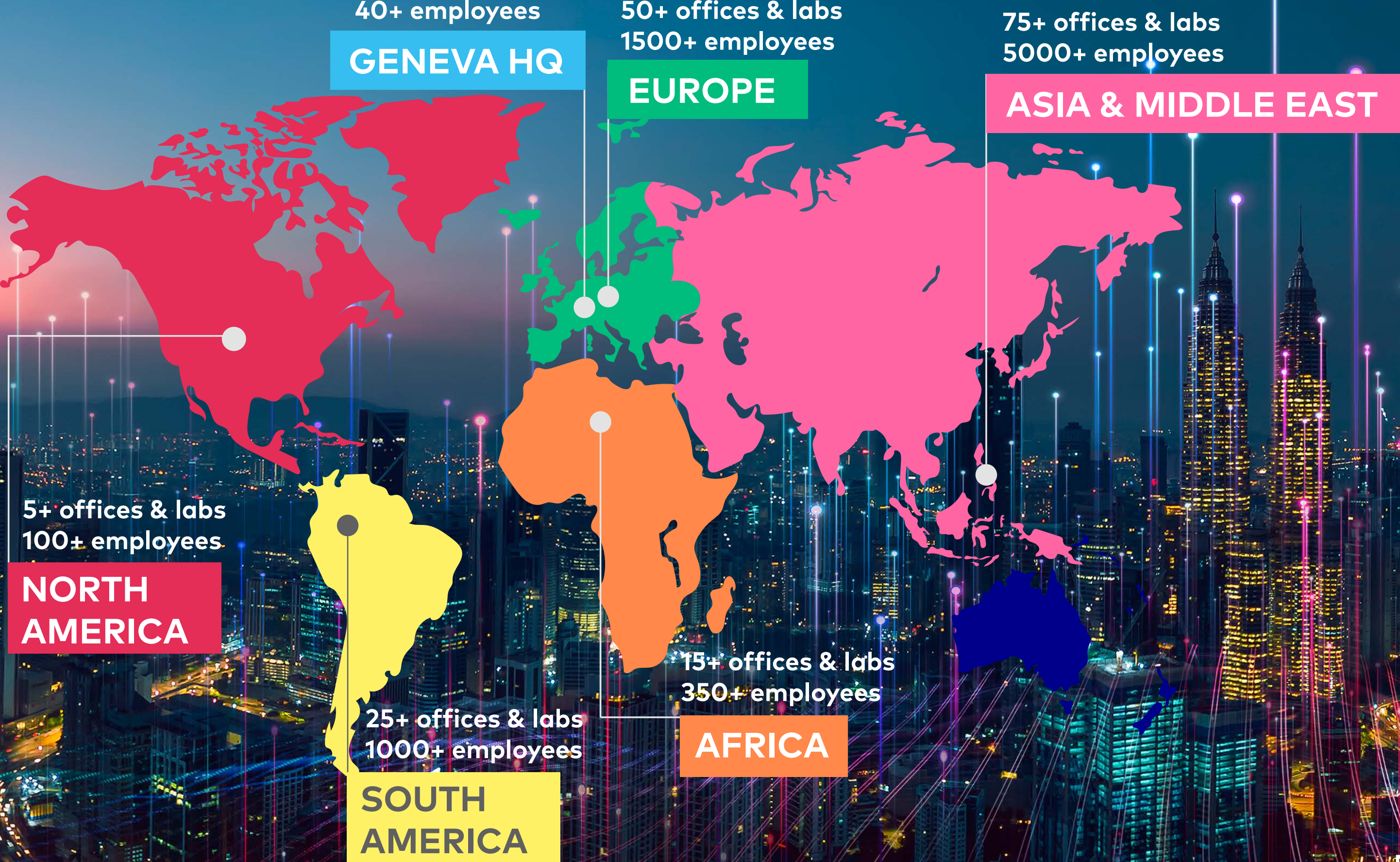
COMPANY OVERVIEW
